

# Dental Care Voucher Program

The Coconino County Health & Human Services Dental Care Vouchers are like money and is used as payment for providing either emergency dental treatment or preventive services for adults who are uninsured or have AHCCCS. **Preventive Care:** provides preventive oral health care at no cost. Preventive dental services (such as an exam, x-rays, cleanings, etc.) will be provided at the Northern Arizona University Dental Hygiene Clinic.

**Emergent Care:** includes emergency dental care up to \$350 at no cost. Services will be provided at North Country HealthCare Dental Clinic in Flagstaff. Only Emergent Vouchers are available in Page and Williams. Income and residency qualifications apply. Inquire in clinic, or by calling 928-679-7355.

**Only one voucher may be given per person per year** (July 1 – June 30).

## WHO IS ELIGIBLE?

Adults 19 and up with no insurance and household income below 201% of the Federal Poverty Level\*

Adults 21 and up with AHCCCS and household income below 201% of the Federal Poverty Level\*

\*Must be a current Coconino County resident

## HOW TO OBTAIN A VOUCHER:

Present in person in Flagstaff, Williams, or Page to complete an application and receive an oral screening to determine the clinical need for emergent dental care and or to receive a preventive voucher.

## WHAT TO BRING:

The following documents are required for Emergent/ Preventive Care Voucher Program applications:

Arizona State-Issued Driver’s License or Photo ID

Proof of current Coconino County residency ((Voter’s Registration, Utility bills, Vehicle records)

Proof of household income (90 days worth of check stubs, Verification from WIC, SNAP, TANF, AHCCCS)



*Voucher recipients in Flagstaff will receive clinical services either at North Country HealthCare Dental Clinic, Timberline Dental or NAU. All other vouchers are to be redeemed in person in Page and Williams.*



# Dental Care Voucher Program

## **Proof of current Coconino County residency, which may include one of the following:**

- Driver's License
- Voter's Registration
- School records
- Welfare/child care records
- Federal, State, or Local (municipal) records
- Support payment records
- Homeowner or tenant records
- Utility bills (i.e., gas, electric, water/sewer, phone, mobile phone, heating, waste disposal)
- Financial (loan, credit, investments, etc.) records
- Insurance documents
- Vehicle records
- Employment records
- Affidavit from homeless shelter

## **To verify income eligibility, one of the following items must be provided:**

- Letter from employer stating income
- Ninety (90) days worth of check stubs from each job
- Verification of Certification from WIC
- Letter of eligibility from SNAP, TANF, or AHCCCS
- Three months (90 days) documentation of unemployment, housing assistance, Social Security, disability, pension or veteran's benefits/military income
- Letters of financial support
