I understand that FERPA prohibits the release of certain information without my written consent. However, directory information may be released without my consent. In any event, pursuant to FERPA, I hereby consent to the disclosure of photos/videos related to me as described herein. I certify that this consent is given freely and voluntarily. I may revoke this consent at any given time by providing written notice of such revocation to the NAU office or employee who maintains this release. I understand that in order to revoke this release, I must present the request in person with NAU accepted photo identification. I understand that this release remains in effect until my written revocation is received by the NAU office or employee.
