



## Seeking an Orthopaedic Nurse Practitioner

### **Job Description**

Seeking a Nurse Practitioner (NP) to meet a community need for orthopaedic care in Kingman, AZ. This role will be to provide office orthopaedic treatment for fracture and soft tissue injuries (30%), osteoarthritis (35%), acute spine injuries (15%) and other general orthopaedic concerns (20%). Applicant will work alongside an experienced orthopaedic NP at our Kingman office. Applicants should have excellent diagnostic and interpersonal skills, and a commitment to team building. Applicants must have a desire to live in a rural community and enjoy a small-town lifestyle.

Responsibilities will include:

- Provide direct assessment, diagnosis, and formulation/implementation of treatment plan for patients presenting with orthopedic illness or injury in the clinic.
- History and physical
- Pre and post-operative exams. Significant time is spent handling patient inquiries regarding preoperative, intra-operative and post operative care.
- Order and interpret diagnostic tests
- Prescribe medications
- Instruct, educate, and counsel patients
- Perform any duties that will expedite the function of the office and enhance patient care
- Manage staff
- Promote practice

- Willing to provide orthopaedic training for the right candidate.
- Graduate of approved Nurse Practitioner program that meets Arizona state licensure requirements.

- Ability to assess, diagnose and plan effective treatment for orthopedic diseases and injuries.
